- Tuition is paid tri-season and is due September 4<sup>th</sup>, December 4<sup>th</sup>, and March 4<sup>th</sup>. Payments made or received after the 8<sup>th</sup> of the month will be assessed a \$25 late fee each month. Costume balance due March 4<sup>th</sup> with tuition.
