Policy Agreement

- Registration, Tuition, and Costume Fees are non-refundable.
- Tuition remains the same regardless of absences, holidays, weather cancellations, short months, long months, natural disasters, pandemics, and/or recital dates.
- In the case of inclement weather, the studio will be closed. It will be on Facebook & text sent if you are signed up. {Please make sure you are signed up for both}.
- **Tuition is paid tri-season and is due September 4th, December 4th, and March 4th. Payments made or received after the 8th of the month will be assessed a \$25 late fee each month.** Costume balance due March 4th with tuition.
- **\$50 Costume Deposit Due October 4th** must be paid by end of Oct to continue.
- Parents are responsible for tuition payments in full until the studio owner is notified in writing of a student's withdrawal.
- **If a student withdrawals from dance after December 30th, the parent is responsible for costume fees.**
- Any student whose account is consistently delinquent will not be permitted to take class until the payment is made.
- There will be a \$25 charge for returned checks, regardless of reason. Money order, cashier's check, or cash only after one returned check.
- I understand that pictures of my child may be used in promotional material and/or the website for Susan's Encore Dance Academy.
- **ALL** Students are required to participate in our annual Rehearsal and Recital(s).
- All non students (including parents) are required to purchase a ticket to attend the recital. At least one parent must attend each night student is performing.
- If a student misses more than 6 classes, the year will not be credited toward trophy.
- Balance must be paid in full in order to purchase tickets for recital.
- Balance must be paid in full in order to receive costumes.
